On July 12, 2007, Meyer spoke about the risks of internet communication in the practice of law during a program co-sponsored by the Pennsylvania Chapter of the American Academy of Matrimonial Lawyers and the Pennsylvania Bar Association's Family Law Section at the Section's semi-annual conference in Cambridge, Maryland. As a panelist for the session entitled "The Complete Resource on Internet Risks for Family Lawyers", Meyer focused on the risks metadata pose to the confidentiality of case information.
